- 3. The abovementioned revised rate of stipend shall come into force w.e.f. the date of Gazette Notification i.e. on 23rd March, 2011. As per GSR 228 (E) Ministry of Labour, Directorate General Employment & Training, New Delhi, Apprenticeship Rules 1992 has been further amended as may be called the Apprenticeship (Amendment) Rules 2011 to revise the minimum prescribed rates of stipend payable to the apprentices under the Act. G.S.R. 228(E).—In exercise of the powers conferred by sub-section (1) of Section 37 of the Apprentices Act, 1961 (52 of 1961), the Central Government, after consulting the Central Apprenticeship Council, hereby makes the following rules further to amend the Apprenticeship Rules, 1992, namely :—

- 1. (1) These rules may be called the Apprenticeship (Amendment) Rules, 2011.
 - (2) They shall come into force on the date of their publication in the Official Gazette.

2. In the Apprenticeship Rules, 1992, in rule 11, in sub-rule (2), for clauses (a), (b), (c), (d) and (e) and the entries relating thereto, the following shall be substituted, namely:---

- "(a) Graduate Apprentices ₹ 3560 per month
- (b) Sandwich Course ₹ 2530 per month (Students from Degree Institutions)
- (c) Technician Apprentices ₹ 2530 per month
- (d) Sandwich course (Students from Diploma Institutions)
 ₹ 2070 per month
- (e) Technician (Vocational) ₹ 1970 per month."
